Voting members not in good standing will not be eligible to vote or place their name on that year's election ballot.

Membership Descriptions:

- <u>Voting Member:</u> Voting membership in Alaska Rural Water Association shall consist of organizations and individuals, both public and private nonprofit, which own public water and/or wastewater facilities serving a population of less than 15,000. Population served is defined as 2.5 people per service connection. A voting member's representative may be elected to the Board of Directors and can be elected as an officer of the Association. **Pricing Varies**
- <u>Individual Member:</u> Any person who is involved in the utility industry that does not otherwise fulfill the Voting, Member-At-Large, or Supporting membership requirements. The Individual membership shall be non-voting and ineligible to hold a position on the Board of Directors or as an officer of the Association. Individual members cannot be employed by a water or wastewater system. **\$95**
- <u>Member-At-Large</u>: Membership may be from any eligible organization or individual as defined under Voting Member. In addition, membership may be from any firm, corporation, or organization that provides goods, materials, professional services, or other service to water or wastewater utilities. A Member-At-Large, or their representative, may be elected to the Board of Directors and can be elected as an officer of the Association if they are eligible as defined under Voting Member. Any Member-At-Large Director that does not meet the membership eligibility criteria defined under Voting Member is not eligible to be an officer of the Association or serve as a national Board member, but is allowed to vote. To be eligible for Member-At-Large Director, the member's primary office must be located in Alaska and the Member-At-Large Director must reside in Alaska. \$350 (Non-voting member)
- <u>Supporting Member:</u> Any public or private nonprofit water/wastewater system that exceeds 15,000 people served and has the same goals as the Association, or any organization that desires to assist the Association. The Supporting membership shall be non-voting and ineligible to hold a position on the Board of Directors or as an officer of the Association. **\$500**
- Nonprofit Supporting Member: Any public or private nonprofit non-utility organization that has the same goals as the Association. The Nonprofit Supporting membership shall be non-voting and ineligible to hold a position on the Board of Directors or as an officer of the Association. \$150
